Tetrodotoxin is among the most toxic substances known to man. Death can occur within 30 minutes. It is extremely dangerous by ingestion, inhalation and skin absorption, or if it enters the bloodstream in any manner. Symptoms of poisoning which include numbness, tingling of the lips and inner mouth surfaces, weakness, paralysis of the limbs and chest muscles, and a drop in blood pressure have been reported within as little as 10 minutes after exposure., To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.
